BilindiĐi üzere, Amerika BirleŐik Devletleri'nde (ABD) tarafından ölkemizin yanı sıra Çin Halk Cumhuriyeti (ÇHC) menŐeli, fren kampanası ürünleri (Brake Drums) ithalatına karŐı anti-damping ve sübvansiyon soruŐtırmaları yürütölmektedir.

ABD Uluslararası Ticaret Komisyonu (USITC) mevcut damping ve sübvansiyon uygulamalarının ABD yerli endüstrisine zarar verip vermediĐine iliŐkin yürüttüĐü soruŐtırmalar kapsamında 9 AĐustos 2024 tarihinde ön kararını açıklamıŐ ve ABD yerli endüstrisinin soruŐtırma konusu ithalattan maddi olarak zarar gördüĐüne dair makul gösterge bulunduĐunu tespit ederek soruŐtırmaların sürdürölmesine karar vermiŐti.

Bu defa, USITC tarafından iletilen e-posta ile (Ek-1) söz konusu soruŐtırmaların nihai aŐaması kapsamında taslak yabancı üretici/ihracatçı soru formu (Ek-2) iletilmiŐtir

Söz konusu soru formu esas itibariyle soruŐtırma konusu üründe ölkemizdeki mevcut, kullanılan ve dönüŐtürölme ihtimali olan kapasiteyi tespit etme amacı taŐımaktadır. Bu çerçevede, edinilecek bulguların USITC tarafından zarar veya zarar tehdidine dair verilecek nihai kararda kullanılacaĐı, verilen bilgilerin bilahare teyit edebileceĐi ve doĐruluĐunun önemli olduĐu hususlarının; soru formunu doldurma niyetinde olan firmalarımızca dikkate alınması önem arz etmektedir.

Bu kapsamda ekte yer alan taslak halindeki yabancı üretici/ihracatçı soru formu ile ilgili yorum ve deĐerlendirmelerinin olması durumunda **4 Ekim 2024** tarihine kadar USITC'ye iletilmesi gerekmektedir.

 - (a) Identify names, addresses, and valid email contact information for the U.S. producers of composite brake drums (including Meritor, if applicable).
 - (b) Indicate whether or not there is any overlap between composite brake drum producers, production processes, and uses and subject brake drum producers, production processes, and uses.
- Please also include the names, addresses, and valid email contact information of any firms that produced in-scope brake drums since January 1, 2022 (including Meritor, if applicable).
- U.S. producers and importers are also requested to identify in an attachment the names, email addresses, street addresses, contact persons, and telephone numbers of their firm's 10 largest customers for brake drums since January 1, 2022, if they have not already provided such information to the Commission.

Please note that the period for which data are to be collected in the final phase of the investigations is subject to change.

The Commission will also be instructing firms to submit their questionnaire response(s) in the fillable MS Word forms via the Commission portal, or by email. All questions including all data tables should be answered in the fillable form. The submission of questionnaire responses in the MS Word fillable form allows the Commission to

electronically extract data from questionnaires and thus, compile, assess, and analyze submitted data more efficiently and promptly. If your client will be unable to complete and return the entire questionnaire in the fillable MS Word form after finalized and issued to companies, please provide the specific reason(s) in your submission for comments on the draft questionnaires.

PART I.—GENERAL INFORMATION

Background. -- This proceeding was instituted in response to a petition filed on June 20, 2024, by Webb Wheel Products, Inc., Cullman, Alabama. Antidumping and/or countervailing duties may be assessed on the subject imports as a result of these proceedings if the Commission makes an affirmative determination of injury, threat, or material retardation, and if the U.S. Department of Commerce (“Commerce”) makes an affirmative determination of dumping and/or subsidization. Brake drums covered by this proceeding are defined as follows:

The merchandise covered by these investigations is certain brake drums made of gray cast iron, whether finished or unfinished, with an actual or nominal inside diameter of 14.75 inches or more but not over 16.6 inches, weighing more than 50 pounds. Unfinished brake drums are those which have undergone some turning or machining but are not ready for installation. Subject brake drums are included within the scope whether imported individually or with non-subject merchandise (for example, a hub), whether assembled or unassembled, or if joined with non-subject merchandise. When a subject drum is imported together with non-subject merchandise, such as, but not limited to, a drum-hub assembly, only the subject drum is covered by the scope.

Subject merchandise also includes finished and unfinished brake drums that are further processed in a third country or in the United States, including, but not limited to, assembly or any other processing that would not otherwise remove the merchandise from the scope of these investigations if performed in the country of manufacture of the subject brake drums. The inclusion, attachment, joining, or assembly of non-subject merchandise with subject drums either in the country of manufacture of the subject drum or in a third country does not remove the subject drum from the scope. The scope of these investigations does not include any products already covered by the antidumping and countervailing duty orders on certain chassis and subassemblies thereof from the People’s Republic of China (A-570-135; C-570-136).

The scope also excludes composite brake drums that contain more than 40 percent steel by weight, while certain brake drums that meet the above criteria and that contain 40 percent or less steel by weight are within the scope.

Brake drums are currently imported under statistical reporting number 8708.30.5020 of the Harmonized Tariff Schedule of the United States (“HTSUS”). They may also be imported under HTSUS statistical reporting number 8708.30.5090 when combined with a hub to form an assembly. The HTSUS provisions are for convenience and customs purposes; the written description of the scope is dispositive.

Reporting of information.--If information is not readily available from your records, provide carefully prepared estimates. If your firm is completing more than one questionnaire (i.e., a producer, importer, purchaser and/or foreign producer questionnaire), you need not respond to duplicated questions.

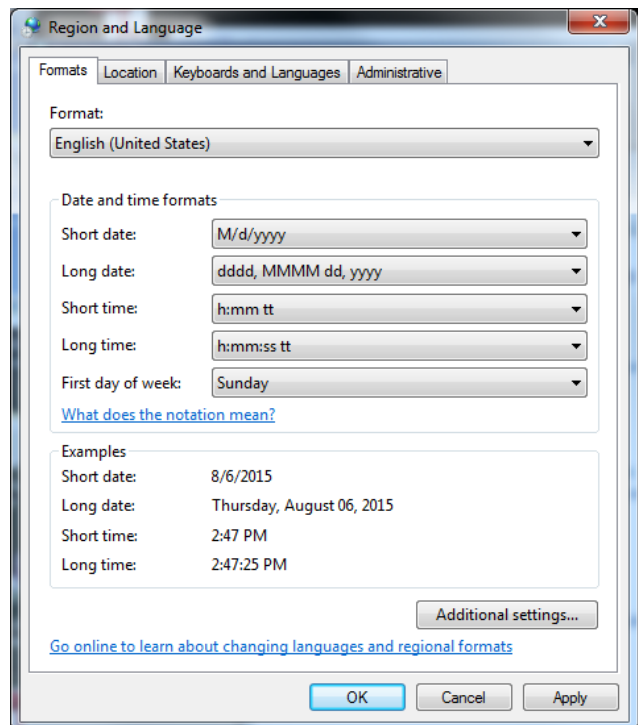
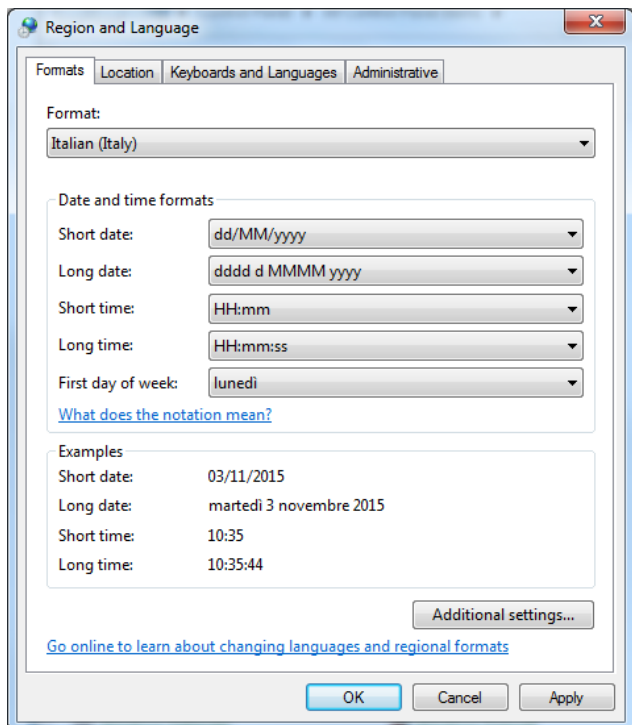
Correcting Valid number error messages.--If you are completing this questionnaire in a country that uses periods (".") to delineate multiples of 1000 (e.g., one million would appear as \$1.000.000 instead of as \$1,000,000), you may be unable to enter in numbers greater than 999 in numeric form fields.
