Sayın Üyemiz,

Ticaret Bakanlığı İthalat Genel Müdürlüğünden alınan bir yazıda, Arjantin Ekonomi Bakanlığı tarafından, Arjantin Gümrük Tarife Pozisyonunda 8422.11.00 olarak sıralanan ülkemiz menşeli “**Bulaşık Makineleri**” ithalatına karşı 23 Nisan 2018 tarihinden bu yana %33 oranında nihai anti-damping vergisi uygulanmakta olup, 3 Nisan 2023 tarihinden bu yana mezkûr önleme ilişkin bir nihai gözden geçirme soruşturması yürütülmektedir.

I am writing to you regarding the reference file through which was processed the review due to the expiration of the term of the antidumping measures applied through the former Ministry of Production Resolution No. 173/2018 to the export operations to the ARGENTINE REPUBLIC of “Domestic type dishwashing machines”, originating in the PEOPLE’S REPUBLIC OF CHINA and the REPUBLIC OF TURKEY.
