Konu: Arjantin/Bazı Sanayi Ürünlerinde Gümrük Vergilerinin Düşürülmesi

Sayın Üyemiz,

Türkiye İhracatçılar Meclisi (TİM)'den alınan bir yazıda, Ticaret Bakanlığı İhracat Genel Müdürlüğünden alınan bir yazıya atfen, Arjantin Resmî Gazetesi'nde **16 Ekim 2024** tarihinde yayımlanan 908/2024 sayılı Başkanlık Kararnamesi çerçevesinde otomobil ve motosiklet lastikleri, plastik ürünler, küçük ev aletleri başta olmak üzere 84 ürün kategorisinde ithalata ilişkin gümrük vergilerinin indirildiği bildirilmektedir.

Anılan yazıda devamla, Arjantin Ekonomi Bakanlığının konuya ilişkin yaptığı açıklamada, Hükümetin rekabeti teşvik etmeyi, ara mal ithal eden sanayiciler ve tüketicilere fayda sağlamayı hedeflediği belirtilerek, bu kapsamda gümrük tarifelerinin otomobil lastiklerinde %35'ten %16'ya, motosiklet lastiklerinde %35'ten %20'ye düşürüldüğü, PET plastik, bakır borular ve tekstil ürünlerinde evvelce % 12,6 ila %35 tarifeye tabi 21 kalemde yeni oranların %2 ila %20 olarak güncellendiği dile getirilmektedir. Bahse konu ürünlerin Güney Amerika Ortak Pazarı "MERCOSUR" tarafından belirlenen tarifenin altında kalacağı ve yaklaşık 100 kalem ürünün, ulusal tarifelerin MERCOSUR tarafından belirlenen oranlardan daha düşük olmasına izin veren **Ortak Dış Tarife İstisnaları Ulusal Listesine** dahil edileceği aktarılmaktadır.

Bununla birlikte, yerli üretimi bulunmayan endüstriyel fırınlar, kazanlar ve motorlar da dahil olmak üzere, daha önce %12,6 ila %35 arasında tarifeye tabi tutulan makine ve makine parçalarında %2-12,6 arasında değişen oranların geçerli olduğu ve bu ürünlerin dayanıklı malların tercihli ithalat tarifesine sahip olmasını sağlayan MERCOSUR Sermaye Malları listesine dahil edileceği belirtilmekte olup söz konusu kararın **17 Ekim 2024** itibarıyla uygulanmaya başlandığı ifade edilmektedir.

Öte yandan, 908/2024 sayılı kararın metni ve konsolide ürün listelerine aşağıda yer alan bağlantı üzerinden ulaşılabilen olup gümrük tarife oranları güncellenen ürünlerin yer aldığı liste ve İngilizce özet not ilişikte sunulmaktadır.

Trade opening: the Government made official the reduction of import tariffs on 89 products

In a framework of trade opening and facilitation of imports, the Government made official the reduction of tariff rates for 89 products. The measure includes tires for cars and motorcycles, plastics, small appliances and household items.

Through Decree 908/2024 <https://www.boletinoficial.gob.ar/detalleAviso/primera/315586/20241016>, published this Wednesday 16 of October in the Official Gazette, it was ordered, first of all, that the tariffs on tires be reduced from 35% to 16%, while those on motorcycles were reduced from 35% to 20%. Both goods were part of the list of products that had rates higher than the Mercosur level.

Likewise, the tariffs on 30 products were reduced so that they are at the regional level (between 9% and 30%), among which are small appliances, coffee, sun creams and gas cylinders. Previously, these articles had tariffs of between 25% and 35%.

The rate was also reduced for 38 machines, which were now included in the list of Capital Goods of Mercosur, which allows durable goods to have a preferential import tariff. These include industrial ovens, boilers and motors not produced domestically, which had a tariff of between 12.6% and 35%, and will begin to have a tariff of between 2% and 12.6%.

The Law also establishes the following on reduction on import taxes:

- As of January 1, 2025, within the framework of the List of Rates Subject to the Transitional Tariff Increase provided for in Annex V of Decree No. 557/23 and its amendments, the tariff treatment for HS CODE 4011.10.00 is established, according to the schedule detailed below:

- From January 1, 2025 to April 30, 2025: TWENTY-FIVE PERCENT (25%).

- From May 1, 2025 to August 31, 2025: TWENTY-FIVE PERCENT (20%).

- From September 1, 2025: application of the established rate of the Common External Tariff (A.E.C.) this is the rate given by Mercosur.

- It is established that, as of July 1, 2025, the tariff items of HS CODE 8711.20.10, 8711.20.20 and 8711.30.00 will be removed from the List of Rates Subject to the Temporary Tariff Increase provided for in Annex V of Decree No. 557/23 and its amendments, date from which they will be subject to the established rates of the Common External Tariff (A.E.C.)

This law is valid from today, October 17, 2024.
