Seventh Plenary Session of the Business Council and Ninth Business Forum of the Conference on Interaction and Confidence Building Measures in Asia (CICA)

Date: 20 November 2024

Venue: Wyndham Garden Hotel (Altay Hall), Astana, Kazakhstan

Aims and Objectives:

- Discuss challenges and opportunities in leveraging artificial intelligence for SME development, enhancing cross-border trade through e-commerce advancements, addressing new challenges in logistics and infrastructure, empowering women in SMEs across the CICA region, and prioritizing sustainable development in SMEs.
- Explore ways to enhance cooperation between small and medium enterprises (SMEs) within the CICA region.
- Create a network among CICA Member States to continuously exchange information on best practices and developments in the mentioned areas.
- Contribute to the reinvigoration of international economic cooperation.

Who Will Benefit?

By generating new ideas and sharing best practices through interactive discussions, SMEs will be better equipped to work in artificial intelligence, e-commerce, logistics and infrastructure, women's empowerment, and sustainable development.

Government officials of the CICA Member States will better understand SMEs' current challenges and opportunities, particularly in the abovementioned areas. This information can inform the formulation of policies more responsive to SMEs' needs, driving economic growth and innovation.

What is the CICA Business Council?

The CICA Business Council is an advisory body within the economic dimension of CICA, promoting cooperation among Member States in the field of SMEs. The Council comprises three members from each of the 28 CICA Member States—two representing business communities and one from a national state body responsible for SME development. The Business Council is overseen by the Chairman of the Board, representing the CICA Chairmanship. Currently, the

Council is chaired by Mr. Raimbek Batalov, Chairman of the National Chamber of Entrepreneurs of Kazakhstan, with deputies from Russia, Thailand, and Türkiye assisting him. The CICA Secretariat coordinates all activities related to these events, including program development and maintaining correspondence with participants.

Program

In December 2024, Azerbaijan will assume the CICA Chairmanship and lead some CICA advisory bodies, including the Business Council. Consequently, Mr. Raimbek Batalov, the current Chair of the CICA Business Council, will present a progress report on the achievements of Kazakhstan's Chairmanship in the Business Council from 2020 to 2024 and introduce the incoming Chair, nominated by Azerbaijan.

Members of the CICA Business Council will deliver presentations on the agenda items, followed by interactive discussions.

Following the Seventh Plenary Session, the Ninth Business Forum will present investment projects from CICA Member States. We invite all interested businesses to showcase their projects and engage with the attending business communities.

Guests

The following speakers are proposed to be invited to the plenary session of the Business Council and the Business Forum: representatives from the Islamic Development Bank, the Eurasian Development Bank, the Asian Bank for Infrastructure Investment, UN Women for Asia Pacific, UNESCAP, and UNESCWA.

Additionally, plans are in place to invite the Afghan business community to participate in the Ninth CICA Business Forum.

Other Organisational Matters

Given the attendance of business circles and government bodies from Member States, there will be opportunities for business-to-business and government-to-government meetings. All participants are expected to cover their own accommodation and meal expenses. The CICA Secretariat will provide simultaneous English-Russian interpretation during the Business Council and Business Forum sessions.
