The following communication, dated and received on 8 November 2024, is being circulated at the request of the delegation of Indonesia.

Pursuant to Article 7.2 and Article 12.1(a) of the WTO Agreement on Safeguards, the Republic of Indonesia hereby wishes to notify the Committee on Safeguards that the Indonesian Safeguards Committee (*Komite Pengamanan Perdagangan Indonesia/KPPI*) hereinafter referred as "the Investigating Authority" has initiated an investigation on the extension of Safeguard Measures on importation of Articles of Apparel and Clothing Accessories under 131 Harmonized System (HS) code according to Indonesia Customs Tariff Book 2022.

**1 THE DATE OF INITIATION OF SAFEGUARD INVESTIGATION**

The investigation regarding the extension of the safeguard measures initiated on 7 November 2024.

**2 PRODUCT UNDER INVESTIGATION**

Articles of Apparel and Clothing Accessories under 131 Harmonized System (HS) code according to Indonesia Customs Tariff Book 2022.
