**Konu:** ABD/Alüminyum Ekstrüzyon Anti-Damping Önlemi ve Sübvansiyona Karşı Telafi Edici Önlem Soruşturmaları

Sayın Üyemiz,

Amerika Birleşik Devletleri'nde (ABD) yerli üreticiler tarafından ülkemizin yanı sıra Kolombiya, Dominik Cumhuriyeti, Ekvator, Hindistan, Endonezya, İtalya, Malezya, Meksika, Çin Halk Cumhuriyeti (ÇHC), Güney Kore, Tayvan, Tayland, Birleşik Arap Emirlikleri ve Vietnam menşeli, alüminyum ekstrüzyon ürünleri (Aluminum Extrusions) ithalatına yönelik dampinge karşı önlem ve yine ülkemizin yanı sıra ÇHC, Meksika ve Endonezya menşeli söz konusu ürünlerin ithalatına yönelik sübvansiyona karşı telafi edici önlem soruşturmaları yürütülmektedir.

Bu çerçevede, 7 Mayıs 2024 tarihinde ABD Resmi Gazetesi'nde yayımlanan ön kararda ilgili kararın yayım tarihi itibarıyla ihracatçılara %45,41 ila % 605,72 arasında değişen oranlarda dampinge karşı geçici önlem uygulanacağı belirtilmiştir.

Bu defa, 5 Haziran 2024 tarihinde ABD Resmi Gazetesi'nde yayımlanan ve Ek 1'de yer alan bildirimde, ön hesaplama larda bulunan önemli hatalar nedeniyle güncellenmiş olan ön karar uyarınca ihracatçılara uygulanacak dampinge karşı geçici önlemin %10,11 ila %48,43 arasında değişen oranlarda hesaplandığı ifade edilmiştir. Öte yandan, mezkur bildirimde nakdi teminatın %9,91 ila %37,26 arasında değişen oranlar üzerinden alınacağı belirtilmektedir.

Öte yandan, ABD Ticaret Bakanlığı Uluslararası Ticaret İdaresi (ITA) tarafından yayımlanan ve Ek 2'de yer verilen bildirim uyarınca, ilgili tarafların ürün tanımına ilişkin görüşlerini (scope comment) 10 Haziran 2024 tarihine kadar ve söz konusu görüşlerle ilgili iddialarını (rebuttal comment) ise 17 Haziran 2024 tarihine kadar ACCESS üzerinden iletebilecekleri belirtilmiştir. Bununla birlikte, anılan görüş ve iddiaların iletildmesine ilişkin olarak ilgili taraflara ek süre tanınmayacağı ve söz konusu tarihlerden itibaren ilgili taraflara ürün tanımı ile ilgili olarak görüşlerini ifade etmeye yönelik ek imkanlar sunulmayacağı ifade edilmiştir.

**Aluminum Extrusions From the Republic of Türkiye: Amended Preliminary Determination of the Less-Than-Fair-Value Investigation**

**AGENCY:** Enforcement and Compliance, International Trade Administration, Department of Commerce.

**SUMMARY:** The U.S. Department of Commerce (Commerce) is amending its preliminary affirmative determination in the less-than-fair-value (LTFV) investigation of aluminum extrusions from the Republic of Türkiye (Türkiye) to correct for significant ministerial errors. The period of investigation is October 1, 2022, through September 30, 2023.

**Background**

On May 7, 2024, Commerce published in the **Federal Register** its preliminary affirmative determination in the LTFV investigation of aluminum extrusions from Türkiye.<sup>1</sup> On May 7 and 9, 2024, respectively, mandatory respondents, Erdoganlar Aluminyum San. ve Tic. A.S. (Erdoganlar) and Sistem Aluminyum Sanayi ve Ticaret A.S. (Sistem) timely alleged that Commerce made significant ministerial errors in calculating their estimated weighted-average dumping margins.<sup>2</sup>

**Scope of the Investigation**

The products covered by this investigation are aluminum extrusions from Türkiye. For a complete description of the scope of this investigation, see the *Preliminary Determination*.<sup>3</sup>

**Legal Framework**

A ministerial error is defined as including “errors in addition, subtraction, or other arithmetic function, clerical error resulting from inaccurate copying, duplication, or the like, and any other similar type of unintentional error which {Commerce} considers ministerial.”<sup>4</sup> A ministerial error is considered to be “significant” if its correction, either singly or in combination with other errors, would result in: (1) a change of at least five absolute percentage points in, but not less than 25 percent of, the weighted-average dumping margin calculated in

the preliminary determination; or (2) a difference between a weighted-average dumping margin of zero (or *de minimis*) and a weighted-average dumping margin of greater than *de minimis* or vice versa.<sup>5</sup> Pursuant to 19 CFR 351.224(e), Commerce “will analyze any comments received and, if appropriate, correct any significant ministerial error by amending the preliminary determination.”

**Analysis of Significant Ministerial Errors**

In the *Preliminary Determination*, Commerce made significant ministerial errors within the meaning of section 735(e) of the Act and 19 CFR 351.224(f) and (g)(1) in calculating the estimated weighted-average dumping margins for Erdoganlar and Sistem. Accordingly, pursuant to 19 CFR 351.224(e), Commerce is amending its *Preliminary Determination* to correct for these significant ministerial errors by revising the rates for Erdoganlar, Sistem, the companies assigned a rate based on adverse facts available (AFA),<sup>6</sup> and all other producers and/or exporters.<sup>7</sup> For a detailed discussion of the alleged ministerial errors, as well as Commerce’s analysis, see the Ministerial Error Memorandum.<sup>8</sup>

**Amended Preliminary Determination**

As a result of correcting these significant ministerial errors, Commerce determines the following estimated weighted-average dumping margins exist:

## Disclosure

We intend to disclose the calculations performed for this amended preliminary determination to parties within five days after public announcement or, if there is no public announcement, within five days of the date of publication of this notice, in accordance with 19 CFR 351.224(b).

## Amended Cash Deposits and Suspension of Liquidation

The collection of cash deposits and suspension of liquidation will be revised according to the rates calculated in this amended preliminary determination, in accordance with section 733(d) of the Act. Because the amended rates for Erdoganlar, Sistem, the companies assigned rates based on AFA, and all other producers and/or exporters result in decreased cash deposit rates, they will be effective retroactively to May 7, 2024, the date of publication of the *Preliminary Determination*. We will also instruct U.S. Customs and Border Protection to issue instructions for requesting a refund of the difference between the amount of cash deposits paid as a result of the application of the *Preliminary Determination* rates and the amount due as a result of the amended preliminary determination rates.

## U.S. International Trade Commission Notification

In accordance with section 733(f) of the Act, we will notify the U.S. International Trade Commission of our amended preliminary determination.

## Notification to Interested Parties

This amended preliminary determination is issued and published pursuant to sections 733(d) and 777(i) of the Act and 19 CFR 351.224(e).

## Polyethylene Terephthalate Resin From the Sultanate of Oman: Preliminary Results of Antidumping Duty Administrative Review; 2022–2023

**AGENCY:** Enforcement and Compliance, International Trade Administration, Department of Commerce.

**SUMMARY:** The U.S. Department of Commerce (Commerce) preliminarily determines that OCTAL SAOC FZC (OCTAL), the sole respondent subject to this administrative review of the antidumping duty (AD) order on polyethylene terephthalate resin (PET resin) from the Sultanate of Oman (Oman), did not make sales of subject merchandise at less than normal value (NV) during the period of review (POR) May 1, 2022, through April 30, 2023. Interested parties are invited to comment on the preliminary results of this administrative review.

## SUPPLEMENTARY INFORMATION:

### Background

Based on timely requests for review, in accordance with section 751(a)(1)(B) of the Tariff Act of 1930, as amended (the Act), on July 6, 2023, Commerce initiated an administrative review of the AD order on PET resin from the Oman with respect to OCTAL covering the POR.<sup>1</sup> On January 24, 2024, Commerce extended the deadline for these preliminary results to May 30, 2024.<sup>2</sup>

For a complete description of the events that followed the initiation of this review, see the accompanying Preliminary Decision Memorandum.<sup>3</sup> A list of the topics discussed in the Preliminary Decision Memorandum is attached as an appendix to this notice. The Preliminary Decision Memorandum is a public document and is on file

## Scope of the Order

The merchandise covered by the *Order* is PET resin having an intrinsic viscosity of at least 0.70, but not more than 0.88, deciliters per gram. The merchandise subject to the *Order* is properly classified under subheadings 3907.60.00.30, 3907.61.0000, 3907.61.0010, 3907.61.0050, 3907.69.0000, 3907.69.0010, and 3907.69.0050 of the Harmonized Tariff Schedule of the United States (HTSUS).<sup>4</sup> Although the HTSUS subheadings are provided for convenience and customs purposes, the written description of the merchandise covered by the *Order* is dispositive. For a full description of the scope of the *Order*, see Preliminary Decision Memorandum.

## Methodology

Commerce is conducting this review in accordance with section 751(a)(1)(B) of the Act. We calculated export and constructed export prices and NV in accordance with sections 772 and 773 of the Act, respectively. For a full description of the methodology underlying our preliminary results of review, see the Preliminary Decision Memorandum.

**SUBJECT:** Second Extension of Time for Interested Parties to Submit Scope  
Comments

The current deadline for interested parties to submit scope comments is June 5, 2024, with rebuttal comments due seven days later, on June 12, 2024. In response to a request from Tesla, Inc.,<sup>1</sup> we are extending the deadline for scope comment and rebuttal comments to **5:00 pm Eastern Standard Time (EST) June 10, 2024**. Rebuttal comments are now due by **5:00 pm EST June 17, 2024**. All submissions to Commerce must be filed electronically via Enforcement and Compliance's Antidumping and Countervailing Duty Centralized Electronic Service System (ACCESS),<sup>2</sup> unless an exception applies.<sup>3</sup>
