**AGREED MINUTES  
OF THE THIRD MEETING  
OF THE JOINT ECONOMIC COMMISSION BETWEEN  
THE REPUBLIC OF TÜRKİYE AND THE KINGDOM OF CAMBODIA**

**10-11 January 2023, Phnom Penh, Cambodia**

The Third Meeting of the Joint Economic Commission between the Republic of Türkiye and the Kingdom of Cambodia was held in Phnom Penh, the Kingdom of Cambodia on January 10-11, 2023 in accordance with the Agreement on Trade and Economic Cooperation between the Government of the Republic of Türkiye and the Government of the Kingdom of Cambodia signed on 3 January 2002.

The Turkish Delegation headed by H.E. Prof. Vahit KİRİŞCİ, Minister of Agriculture and Forestry of the Republic of Türkiye, and the Cambodian Delegation headed by H.E. Mr. PAN Sorasak, Minister of Commerce of the Kingdom of Cambodia, welcomed the holding of the Third Meeting of the Joint Economic Commission, as well as the work done by the two sides during the intersessional period.

The Agenda of the Meeting and the composition of the Delegations of both sides are attached as Annex I and Annex II, respectively.

The deliberations of the Third Meeting of the Joint Economic Commission took place in a cordial atmosphere of mutual respect and understanding, reflecting the bilateral friendly relations and the aspiration of both sides to further strengthen, develop and diversify their bilateral trade and economic cooperation on the basis of mutual benefits.

With immense satisfaction, both sides acknowledged that the continued intensification of the bilateral interactions in the last decade, which was attested by sequence of high-level meetings and the implementation of the signed agreements as well as memoranda of understanding, have further enhanced and strengthened the diplomatic and economic relations.

Both sides welcomed Türkiye's Asia Anew Initiative, aiming at broadening bilateral relations on the basis of common interests and objectives in a mutually beneficial manner.

Both sides welcomed the official inauguration ceremony of the Royal Embassy of Cambodia to the Republic of Türkiye in Ankara on 27 February 2022, and emphasized that the existence of respective resident embassies in the two countries will further elevate bilateral relations between Türkiye and Cambodia.

Both sides placed great emphasis upon the importance of deepening cooperation through direct dialogues in accordance with the prioritized sectors including trade and investment, private sector, industrial cooperation, halal affairs, standardization, technical barriers to trade and technical regulations, agriculture, transportation such as shipbuilding, railway and civil aviation, health, education and tourism.

In this respect, both sides agreed to the extent possible and applicable to establish sub-committees relative to each prioritized sector being a catalyst for development of closer multi-sectoral cooperation as stipulated in Article VIII of the signed Agreement on Trade and Economic Cooperation, and through which to initiate a joint action plan for effective implementation of the main sectors of cooperation set forth.

In agreement with the articles of the Agenda of the Meeting accepted by both sides, the following decisions and recommendations of common interest were adopted.

## **I. MULTILATERAL COOPERATION**

Both sides expressed commitment to multilateralism, rules-based order, regional peace, security and stability, mutual respect, equality, political independence and non-interference as the fundamental bases for inclusive growth and shared prosperity. The Cambodian side adhered to these principles during her ASEAN Chairmanship in 2022, endeavoring to maintain peace and stability, to promote sustainable development and prosperity, as well as to enhance the ASEAN Community building efforts by reinvigorating and expanding partnerships with external partners through the ASEAN-led mechanisms while maintaining the ASEAN Centrality in the evolving regional architecture. The Turkish side expressed its willingness to cooperate with Cambodia in developing its relations with the ASEAN Community.

Both sides acknowledged that the COVID-19 pandemic is a common crisis causing immeasurable disruption and impacts upon global linkages and mobility, and noted that the concerted commitments and efforts in combating this pandemic is essential to achieve a swift post-pandemic economic recovery.

The Cambodian side presented its compliment to the Turkish side's steadfast commitment to joining the world in the effort to develop COVID-19 vaccine of Turkovac. In tandem with that effort, the Royal Government of Cambodia has successfully contained the outbreak with high-rate administration of vaccination across different age groups, thereby enabling the country to fully reopen for travels, businesses, investment and tourism.

The Cambodian side acknowledged the importance of the past training programs in relation to diplomacy and World Trade Organization (WTO) issues organized by the Turkish side in the past few years, which equipped the Cambodian trainees with practical knowledge beneficial to their professional endeavours, enabling them to address real-world problems.

Both sides reiterated the importance of promoting commercial cooperation, economic integration and facilitating regional trade among the member states of the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP).

Both sides, in accordance with their domestic laws and regulations, called upon exchange of information between the Parties for implementation of trade facilitation standards set by the WTO, World Customs Organization and other international organizations.

The Turkish side expressed its willingness to carry out joint activities and make joint meetings between the respective “National Trade Facilitation Committees” of the two countries established within the context of WTO Trade Facilitation Agreement.

The Turkish side expressed its readiness to support the Kingdom of Cambodia on technical provisions notified on Category C, within the context of the WTO Trade Facilitation Agreement.

## **II. TRADE AND INVESTMENT COOPERATION**

### **1. Bilateral trade**

Both sides welcomed the momentum of bilateral trade, signifying a fruitful consequence of strenuous efforts and concerted cooperation for mutual benefits. Both sides acknowledged that while the trade volume between Türkiye and Cambodia has grown noticeably for the last decade, the volume of trade in absolute terms remains moderate, leaving untapped potentials and more room for further efforts.

Both sides, in this connection, agreed to leverage joint efforts and formulate a strategy to substantially increase bilateral trade in goods and services.

Both sides further agreed to exchange lists of export companies and potential export commodities as well as to facilitate joint trade promotional activities such as joint business matching, investment fora, exhibitions as well as roadshows of potential products, which can immediately produce amplitude of business and investment opportunities. In this connection, the Cambodian side would like to extend invitation to the Turkish side to the annual Cambodian and Import-Export Goods Exhibition to be held in every December in Phnom Penh.

Both sides agreed to facilitate the arrangement of business trips and seminars between the two countries in order to present the updates on the trade and investment environment and regulations of each country.

Both sides agreed to hold an exploratory meeting to explore possibilities for a preferential trade arrangement.

### **2. Investment**

The Cambodian side informed the new Law on Investment of the Kingdom of Cambodia, which aims to increase her competitiveness and attractiveness; generate openness, transparency and predictability; enhance administrative procedures, and provide smart incentive schemes together with investment guarantees.

The Cambodian side strongly encouraged the Turkish business community to set up production facilities and participate in the regional value chain for exports particularly in the areas of

agriculture, agro-industry, food processing, manufacturing products, automotive, electronics and agricultural commodities such as rice, mango, banana and cashew nuts.

Both sides agreed to further step-up bilateral investment promotion through the exchange of focal contacts of competent authorities concerned, the sharing of information pertaining to investment, and the facilitation of economic, business and investment events, exhibitions, and trade fairs for either the Cambodian delegations visiting Türkiye or the Turkish delegations visiting Cambodia.

### **3. Customs Cooperation**

Both sides acknowledged the important role of the customs cooperation and mutual administrative assistance in facilitating trade with the aims at strengthening, promoting and developing cooperation and mutual assistance in accordance with respective laws and regulations on matters pertinent to customs control of imports and exports of goods.

To this end, both sides agreed to explore the possibility of establishing Memorandum of Understanding on Customs Cooperation, in addition to exchanging the focal points on a regular basis for effective communication.

### **4. Turkish-Cambodian Business Council**

Both sides underlined an important role of the Turkish-Cambodian Business Council in bridging the gap between the business communities of the two countries through closer contacts, business matching and networking events. For effective communication and implementation of joint activities, both sides decided to exchange the focal points on a regular basis.

In the effort to further strengthen cooperation, both sides welcomed successful business trip of the Cambodia Chamber of Commerce to Ankara, Türkiye on 25 February – 01 March 2022. Both sides agreed to encourage business trips between the two countries and explore joint projects in the fields of agriculture, food industry, construction, energy, mining, technology and in all other relevant sectors.

Both sides expressed congratulations and gratitude on the successful implementation of the virtual Turkish-Cambodian Business Forum which convened on 15 September 2021, and agreed to jointly organize another momentous business forum in 2024 in commemoration of the 65<sup>th</sup> anniversary of the establishment of diplomatic relations between the two countries.

In alignment with the common aspiration of expanding bilateral trade volume, the Turkish-Cambodian Business Council agreed to scale up its efforts in developing a pragmatic action plan, as well as putting forward or formulating investment projects either through Business-to-Business (“B2B”) or Public Private Partnership (“PPP”) in accordance with potential areas of the two countries.

### III. ECONOMIC COOPERATION

#### 1. Industrial Cooperation

Both sides agreed on exchanging information and expertise in industry-related issues, and stepping up efforts to initiate joint investment projects between the two governments, business circles or both as means and ways to diversify composition of bilateral trade especially in the following priority industries:

- agro-processing industry;
- heavy and high-tech industry;
- parts and assembly industry;
- electrical and electronics industry;
- mechanical and machinery industry;
- and latest digital technology such as artificial intelligence, blockchain, cloud, big data, 5G, and Internet of Things (“IoT”).

Both sides agreed to explore the possibility of arranging a study visit to industrial zones in Türkiye in due course, and to support and facilitate future study visits of either Cambodian business delegation to Türkiye or Turkish business delegation to Cambodia, as well as keeping each side informed of business and investment opportunities in their respective countries.

#### 2. Science, Technology and Innovation (“STI”)

Both sides expressed their willingness to:

- enhance cooperation in the areas of science, technology and innovation;
- share best practices and experiences in science, technology and innovation;
- organize activities to bring technology firms and entrepreneurs of both countries together;
- jointly conduct research on industrial technology, including agro-industry, food and biomedical;
- and develop cooperation regarding the best practices and lessons learned in digital transformation, particularly in the field of digital government, digital economy, and digital society.

The Cambodian side proposed to establish a Memorandum of Understanding on Science, Technology and Innovation between the competent authorities of both sides.

The Cambodian side proposed for the Turkish side’s consideration to have a study visit to STI parks in Türkiye on a mutually agreed date in order to gain insights to a greater extent possible for the future development of Cambodian STI parks.

Both sides acknowledged the importance of strengthening the science, technology and innovation capacity of the Least Developed Countries (LDCs) to bring about structural transformation and sustainable development. Hence, both sides recognized the significance of

the work of the United Nations Technology Bank for LDCs located in Gebze/Türkiye and reiterated their support to the Bank to help its efforts in bridging the digital divide between developed and developing countries. The Turkish side encourages the Cambodian side to benefit from the services and projects provided by the Bank.

### **3. Post, Telecommunications and ICT (Information and Communications Technology)**

Both sides agreed to cooperate on and identify the following fields of common interest for both the medium and long terms:

- strengthening the communication and mutual support between the two countries in postal sector within the framework of the Universal Postal Union;
- and strengthening collaboration in sharing experiences and capacity building on policy and regulation management, digital transformation, cybersecurity, and latest digital technologies.

### **4. Halal Cooperation**

Both sides agreed to strengthen cooperation in the halal affairs through establishment of a Joint Working Group for improving the cooperation in Halal standardization, conformity assessment (testing, certification, inspection) and accreditation. To assist in the establishment and its related arrangements, both sides thereby agreed to exchange their respective contact persons at their earliest convenience.

The Halal Accreditation Agency ("HAK"), the sole authority in Türkiye to provide halal accreditation services, expressed its readiness to provide trainings on the Organization of Islamic Cooperation ("OIC") / Standards and Metrology Institute for Islamic Countries' ("SMIIC") standards upon Cambodian side's request.

The Turkish side expressed Turkish Standards Institution's ("TSE") readiness to develop and apply the Halal project proposal submitted to Cambodian side through Turkish Cooperation and Coordination Agency ("TİKA") in 2016 to establish Halal quality infrastructure in Cambodia.

Further, in a bid to reinforce concerted halal cooperation between the two countries, both sides expressed their contentment due to the finalization of the Memorandum of Understanding in the Field of Halal Accreditation, Conformity Assessment and Other Related Processes between the Ministry of Industry, Science, Technology and Innovation of Cambodia and the Halal Accreditation Agency of Türkiye. Both sides expressed their willingness to sign this MoU on a mutually agreed time.

Both sides expressed their readiness to strengthen cooperation in the Halal affairs, and consumer protection between the Consumer Protection Competition and Fraud Repression Directorate-General ("CCF") of the Ministry of Commerce of Cambodia and the relevant authorities of Türkiye.

## **5. Standardization**

Both Sides agreed to jointly explore mechanisms to foster the implementation of the MoU on Technical Cooperation Between the Turkish Standards Institution (“TSE”) and the Institute of Standards of Cambodia (“ISC”) which was signed on 19 September 2017.

TSE and ISC reiterated their renewed assurances and steadfast commitment to supporting one another at international platforms such as the International Organization for Standardization (“ISO”).

## **6. Technical Cooperation in Metrology**

Both sides underlined the paramount importance of metrology to ensure conformity, thereby reaffirming their keenness to expedite the conclusion of a MoU on Metrology, and develop cooperation between National Metrology Center (“NMC”) of Cambodia and the Scientific and Technological Research Council of Türkiye’s National Metrology Institute in the fields of metrology, calibrations, measurement systems and quality control in the following topics:

- bilateral comparisons;
- exchange of personnel;
- development of metrological equipment/instruments;
- joint research projects in metrology;
- organization of joint meetings and conferences;
- and providing traceability.

## **7. Micro, Small and Medium Enterprises (“MSMEs”)**

Both sides agreed to explore mechanisms to foster the implementation of the MoU on Micro, Small and Medium Enterprises Cooperation between General Department of Small and Medium Enterprises & Handicrafts (“GDSMEH”) of the Kingdom of Cambodia and Small and Medium Enterprises Development Organization of the Republic of Türkiye (“KOSGEB”), which was signed on 18 October 2019.

The Cambodian side appreciated the Turkish side’s renewed willingness to share its knowledge and experience pertaining to KOSGEB models and MSMEs incentive models, in particular digitalisation support, business and technology incubators, developing entrepreneurship culture and training for development of MSME related organizations, MSMEs, and entrepreneurs.

The Cambodian side also underlined the importance of improving productivity, innovation and enhancing capacity of its MSMEs, particularly through promoting financial literacy, providing capacity-building programs and digitalisation support, and promoting technology and knowledge transfer mechanisms.

## **8. Contracting and Engineering Consultancy Services**

Noted the vital importance of cooperation on contracting and engineering consultancy services as mutually emphasized during the Second Meeting of the Joint Economic Commission, the Cambodian side welcomed the relevant Turkish companies and institutions to explore the investment opportunities.

## **9. Agriculture, Forestry and Fisheries**

Acknowledging the important role of agriculture in maintaining food security amidst the impacts posed by the climate change and the increased food price, both sides reiterated their commitment to expediting the implementation of the MoU between the Government of the Republic of Türkiye and the Government of the Kingdom of Cambodia on the Cooperation in the Field of Agriculture, which was signed on 21 October 2018.

Both sides expressed their gratitude for the Agricultural Working Group meeting held online by the technical delegations of the two countries on 14 October 2022.

Both sides agreed to promote cooperation in the following fields:

- strengthening cooperation on plant and animal health and SPS;
- cooperation on combating desertification, land erosion, land degradation and drought;
- encouraging investment of Turkish and Cambodian companies in processing and marketing of agricultural products;
- collaborating on aquaculture and aquacultural trade and sharing knowledge and experience;
- sustainable management of forests considering several benefits;
- and inventory of non-wood forest products and improving their management and marketing opportunities.

## **10. Water Resources Management**

Both sides encouraged the Ministry of Agriculture and Forestry of the Republic of Türkiye and the Ministry of Water Resources and Meteorology of the Kingdom of Cambodia to seek the appropriate time to start the implementation of Cooperation Agreement between the Government of the Republic of Türkiye and the Government of the Kingdom of Cambodia in the field of water, that was signed in Istanbul on 21 October 2018 during the visit of Samdech Akka Moha Sena Padei Techo HUN SEN, Prime Minister of the Kingdom of Cambodia, to Türkiye on 20-22 October 2018.

The Turkish side proposed to hold the first meeting of the Water Joint Committee on a mutually agreed date.

Both sides agreed to promote cooperation in the following fields:

- preparation of river basin management plans;
- preparation of flood and drought management plans;
- monitoring and management of water quality;
- impacts of climate change on water resources;
- effective and efficient use of water, reuse and treatment of wastewater and drainage water from agricultural irrigation;
- and preparation of sectoral water allocation plans.

## **11. Biodiversity**

Both sides agreed to cooperate on the conservation and sustainable use of biological diversity.

The Turkish side would like to invite Cambodia to the 16<sup>th</sup> Conference of Parties (COP16) of the Convention on Biological Diversity to be held in Türkiye in 2024. The Cambodian side welcomed the invitation.

The Turkish side called upon Cambodian support regarding Türkiye's candidacy to host the 31<sup>st</sup> Conference of the Parties to the UN Framework Convention on Climate Change to be held in 2026. The Cambodian side took note of the proposal.

## **12. Transportation**

### **12.1. Cooperation in Shipping Industry**

Considering the untapped potentials in the field of shipping industry as highlighted in the second JEC meeting, both sides noted the opportunities for cooperation in the field of shipbuilding and expressed their readiness to develop cooperation in the following areas;

- creation and implementation of modern technologies for ship design, shipbuilding, yacht construction, ship repair and maintenance and ship recycling of a process-layout preparation;
- modernisation/construction of shipyards (docks) in Türkiye and Cambodia;
- and ship and shipyards design, shipbuilding, yacht construction, ship repair and maintenance and ship recycling training for engineers and technical personnel.

### **12.2. Cooperation in Railway Sector**

Both sides reiterated their collective desire to cooperate on:

- maintenance and modernization of the towing vehicles;
- provision of technical cooperation, training and consultancy services;
- and sharing of experience and information in the railway area.

### 12.3. Civil Aviation

In accordance with the existing Air Service Agreement and MoU between the Republic of Türkiye and the Kingdom of Cambodia, both sides acknowledged that air connectivity is very important for the promotion of tourism cooperation and people-to-people contact and agreed to encourage the respective civil aviation authorities and their own airlines to explore the possibilities to have direct flights between the two countries.

Both sides encouraged the civil aviation authorities of both countries to expand traffic rights between the two countries which will be playing important roles for promoting air connectivity of passengers and cargo flights between and beyond Türkiye and Cambodia.

The Turkish side requested that the passenger and cargo frequency right, which has a total of 21 frequencies per week, be separated from the cargo right and revised to be unlimited or at least 14 frequencies, provided that the passenger frequency right remains as 21 frequencies.

The Cambodian side welcomed the request of Turkish side and suggested that the exchange of traffic rights should be arranged under the bilateral air consultations of both civil aviation authorities. The Cambodian side expressed gratitude for the Turkish side's reassertion of providing the training in civil aviation for Cambodian officials, as well as cooperation in areas related to all aviation activities. The Turkish side expressed that they are ready to provide training for Cambodian officials following the notification of training subjects and the number of participants by Cambodia.

### 13. Health

Both sides reiterated their common interest in the area of public health cooperation through exchange of knowledge, experience and best practices on public health issues especially in strengthening health systems and communicable diseases.

Further, both sides expressed their willingness to sign a MoU in the field of health covering medicines, medical equipment, international patient treatment, the supply of drugs and medical devices, health information technology, health investments, as well as the development of alternative trade routes with the aim of increasing win-win trade activities. For this purpose, the Turkish side will provide a draft text for the Cambodian side's review. Besides, both sides agreed to establish a technical working group as well as focal points for effective coordination.

### 14. Education and Higher Education

Both sides attached great importance to the augmentation of cooperation in the field of education for broader development of human resources and school quality, in parallel with strengthening the economic relations. Both sides thereby reaffirmed their unwavering commitment to:

- implementing the Agreement on Cooperation in the field of Education, and the Agreement on Cooperation in the field of Sports, which were signed on 21 October 2018 in Türkiye;

- signing the MoU regarding the status and basis of educational activities of Turkish Maarif Foundation in Cambodia during a visit by the authorities of the Foundation to Cambodia;
- facilitating procedures regarding the establishment of legal personality of Turkish Maarif Foundation in order to conduct educational activities in Cambodia;
- and initiating the collaborative activities in the field of STEM and digital education.

Both sides expressed their willingness to organize capacity building programmes on priority areas that will be specified by respective authorities of the two countries.

The Cambodian side proposed to the Turkish Side to consider joint-policy research and publication to gear up research culture and knowledge society.

Both sides emphasized the importance of signing a MoU between the Council of Higher Education of Republic of Türkiye and the Ministry of Education, Youth and Sports of Kingdom of Cambodia regarding cooperation in the field of higher education to explore scientific and academic development opportunities and to achieve aimed academic mobility.

The Turkish side acknowledged the significance of informing the Council of Higher Education in Türkiye about the higher education fairs which will be held in Cambodia.

The Turkish side underlined the importance of reciprocal visits in promoting the mutual acknowledgement of their universities and higher education systems.

Both sides emphasized that the allocation of scholarships to their citizens in the fields of language courses and tertiary education will contribute positively to the relations of both countries. The relevant authorities of both countries will consider to cooperate on the scholarships allocated to their respective students.

## **15. Tourism**

Both sides appreciated the intensification of mutual support and cooperation in tourism sector. With bona fide goodwill of collaboration and cooperation, Cambodia is strongly committed to frequently participating in East Mediterranean International Tourism and Travel Exhibition and International Cooperation Platform held in Istanbul, Türkiye aimed to increase number of Turkish tourists and investors to Cambodia.

To pave the way forward the optimized level of cooperation in tourism, both sides further agreed to exploit every mechanism possible particularly in the following forms:

- organize study visits, technical tours and familiarization trips (“FAM-trips”), upon request, for government officials, tour operators, travel agents and press members of the two countries;
- seek to augment more schedule direct flights to both countries;
- seek the Turkish side to assist in tourism human capital development through making trainers training in Cambodia;

- conduct exchanges of information, expertise and experiences on tourism practices;
- encourage investors in both countries to invest in tourism projects on a reciprocal basis;
- and encourage to promote and market tourist destinations of the two countries on a reciprocal basis through all means of marketing and promotion.

In accordance with the Agreement on Tourism Cooperation between Türkiye and Cambodia signed on 21 October 2018 in Istanbul, Türkiye, both sides welcomed the organization of the inaugural meeting of the Joint Tourism Working Group, which was adjourned in 2021 due to the unprecedented global pandemic of COVID-19, and is rescheduled to be organized in Cambodia in 2023.

#### **Monitoring, Time and Venue of the Next Session**

Both sides agreed on exchange of contact information of the focal points which will be responsible for monitoring successful implementation of the tasks determined in the Agreed Minutes of the Third Meeting of the Joint Economic Commission between the Republic of Türkiye and the Kingdom of Cambodia.

Both sides agreed that the Fourth Meeting of the Joint Economic Commission between the Republic of Türkiye and the Kingdom of Cambodia will be held in Ankara on the date to be specified mutually through diplomatic channels.

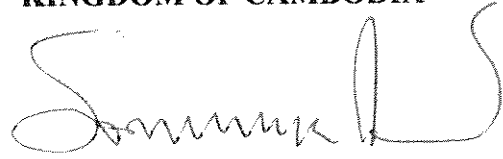
