SUBJECT: Notification of Intent to issue an Invitation for International Bidding (IFIB) for Counter UAS (Unmanned Aerial Systems) Capabilities

In accordance with the stipulations of the Bi-SC Procurement Directive 60-70, Annex B, and Procedures for International Competitive Bidding (2015 Edition) the following information is provided on an Invitation for International Bidding (IFIB) that this Headquarters has the intention to release:

IFIB REFERENCE: IFIB-ACT-SACT-26-07

TITLE OF IFIB: Contractor Support for Counter UAS (Unmanned Aerial Systems) Capabilities

REQUIREMENT: HQ SACT gives Notice of the Intent to issue an Invitation for International Bid (IFIB) for the provision of contracted services.

Massed, low-cost UAS incursions repeatedly strain NATO's defensive posture. The Alliance must invest in solutions to ensure a balanced cost-per-shot ratio, avoiding disproportionate expenditure against inexpensive, scalable threats. The low layer remains the most urgent and vulnerable gap; mitigation requires field-ready capabilities that can detect incoming threats early to protect the Alliance's territorial sovereignty and inform the long-term modernization of NATO's integrated defence architecture.

As part of the Layered Counter UAS Initiative (LCI-X), HQ SACT intends to solicit contractor support to rapidly deploy and field-test in real-world conditions capabilities that address this gap. LCI-X will be executed in 2026 through a series of testing and experimentation events: two small-scale events (each approximately 2 weeks) and one or two large-scale events (each approximately 3-4 weeks). These events will take place in various locations in Europe and one location in the United States.

For this purpose, HQ SACT is seeking contractor support that fulfills two streams:

- Blue Force / Defence as a Service: sensors, effectors, and C2 systems that together provide layered defence. This includes early detection, threat tracking and classification, and layered defeat options (soft-kill and hard-kill), delivered as a service (lease, operators, sustainment, training).
- Red Force / Threat Emulation as a Service: UAS capable of reconnaissance, decoying, and attack roles, able to operate in swarm or massed launch configurations to stress-test the layered defence.

TYPE OF CONTRACT: Firm-fixed Price, deliverable based

PERIOD OF PERFORMANCE: Award (estimated Feb 2026) to 31 Dec 2026

BIDDING PROCEDURE: The intended procurement method will be International Competitive Bidding in accordance with Bi-SC Procurement Directive 60-7. The contract award will be determined based on the contractor(s) that offers the Best Value to NATO.

FUNDING: Estimated value up to EUR 10M

ISSUE DATE: Estimated 21 November 2025

BID CLOSING DATE: Estimated 9 January 2026

ELIGIBILITY: Companies that have performed similar contracts within the last three years substantially similar in scope to the requirement described in the solicitation.

DELIVERY LOCATION(S): The contract will cover services being accomplished in various locations in Europe and USA that will be specified in the IFIB Statement of Work

PARTIAL BIDDING: Partial Bidding is authorized.
