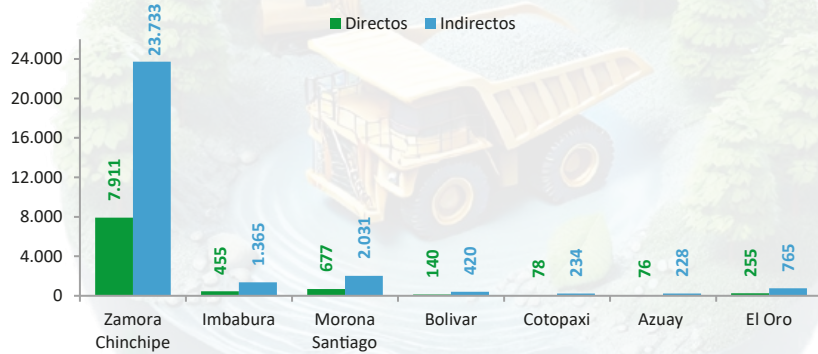

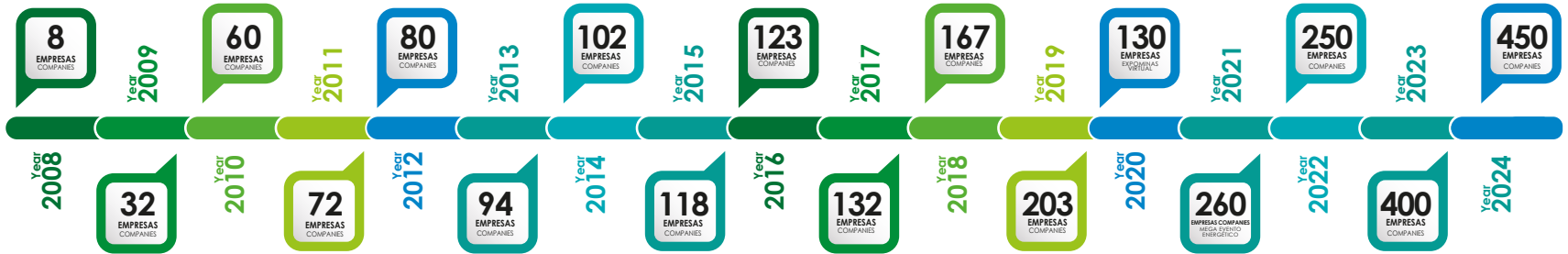

CONDITIONS OF PARTICIPATION

OBLIGATIONS - INSTALLATION AND OPERATION OF THE EXHIBIT SPACE

OBLIGATIONS RELATED TO THE INSTALLATION AND OPERATION OF THE STANDS

The CONCESSIONAIRE, once their participation contract has been submitted, must pay a 20% advance payment for the stand reservation within a maximum period of 30 days. Otherwise, the contract will be canceled, and the space reservation will be voided. The remaining balance can be divided into installments as per the payment options detailed in the contract.

The CONCESSIONAIRE must occupy the assigned space or stand starting on October 18, 2025, from 08:00 and have completed the decoration of the stand by 10:00 on October 20, 2025. They must return it to the GRANTOR in the same condition in which it was received, free of any items, by no later than 14:00 on October 24, 2025. If any damage is found, the GRANTOR may hire repairs, which the CONCESSIONAIRE must reimburse in full within 8 days from the notification of payment completion.

The CONCESSIONAIRE is prohibited from assigning or subleasing the assigned space.

All materials used for the installation and decoration of the stands must be non-flammable or properly treated for such purposes. Under no circumstances should the space be used to store chemical and/or hazardous substances.

The CONCESSIONAIRE must maintain the assigned space in perfect condition, keeping it clean and organized throughout the event duration.

The CONCESSIONAIRE will be solely responsible for the safety and integrity of all equipment, goods, furniture, elements, and materials exhibited in the stand, with the GRANTOR having no liability for any loss, theft, or damage.

The GRANTOR reserves the exclusive right to permit or deny entry to anyone at the event, which must be respected by the CONCESSIONAIRE.

The CONCESSIONAIRE may not place advertising or promotional materials above the height of the stand or display or promote products unrelated to the event's purpose. The maximum construction height allowed is specified in the Exhibitor Manual. If the stand exceeds the height of the neighboring stand, the CONCESSIONAIRE must cover the back of the stand with white panels or fabric to avoid affecting the visibility of neighboring stands. This material must not feature any type of advertising.

Before the stand's delivery, the CONCESSIONAIRE must submit a design of the decoration to the GRANTOR for review, who may suggest changes that the CONCESSIONAIRE must comply with.

The CONCESSIONAIRE must ensure that their staff maintains appropriate conduct, as the event is open to the

public. Consequently, alcohol consumption will be regulated during the event days and times, with information provided in advance by the Organizing Committee.

Since this is a professional event focused on business generation, the use of music, whether prerecorded or performed by live musicians, is prohibited during event hours, as specified in the Exhibitor Manual.

Communal spaces or circulation areas such as hallways, lounges, or open spaces, including those outside the venue, cannot be used by the CONCESSIONAIRE for displaying promotional items, as these are exclusively for the GRANTOR's use. The CONCESSIONAIRE may only engage in activities and distribute promotional materials at their designated stand.

EARLY TERMINATION AND RECOVERY OF THE ASSIGNED SPACE: If the CONCESSIONAIRE fails to comply with any of the obligations specified in this annex, the GRANTOR may unilaterally terminate the stand concession by simple written notice, with no need for any authority declaration. Any payments made until the termination will remain with the GRANTOR, who may freely assign the space to another company.

If the event referred to in this annex does not take place on the specified dates due to the GRANTOR's responsibility, the GRANTOR will return the full amount paid by the CONCESSIONAIRE unless both parties agree to reschedule the event.

In the event of force majeure or an unforeseeable event, both parties will reach a mutual agreement.

If the CONCESSIONAIRE cancels their participation and has already paid for their space reservation, the amounts will not be refunded or applied to other fees, such as membership or other charges.

If the CONCESSIONAIRE has not returned the space to the GRANTOR as specified in this contract, the GRANTOR may recover the physical possession of the space, even without the CONCESSIONAIRE's presence, and remove all goods and furniture, placing them in storage at the CONCESSIONAIRE's expense.

The CONCESSIONAIRE unconditionally and irrevocably accepts the procedures for returning the stand or space and for early contract termination.

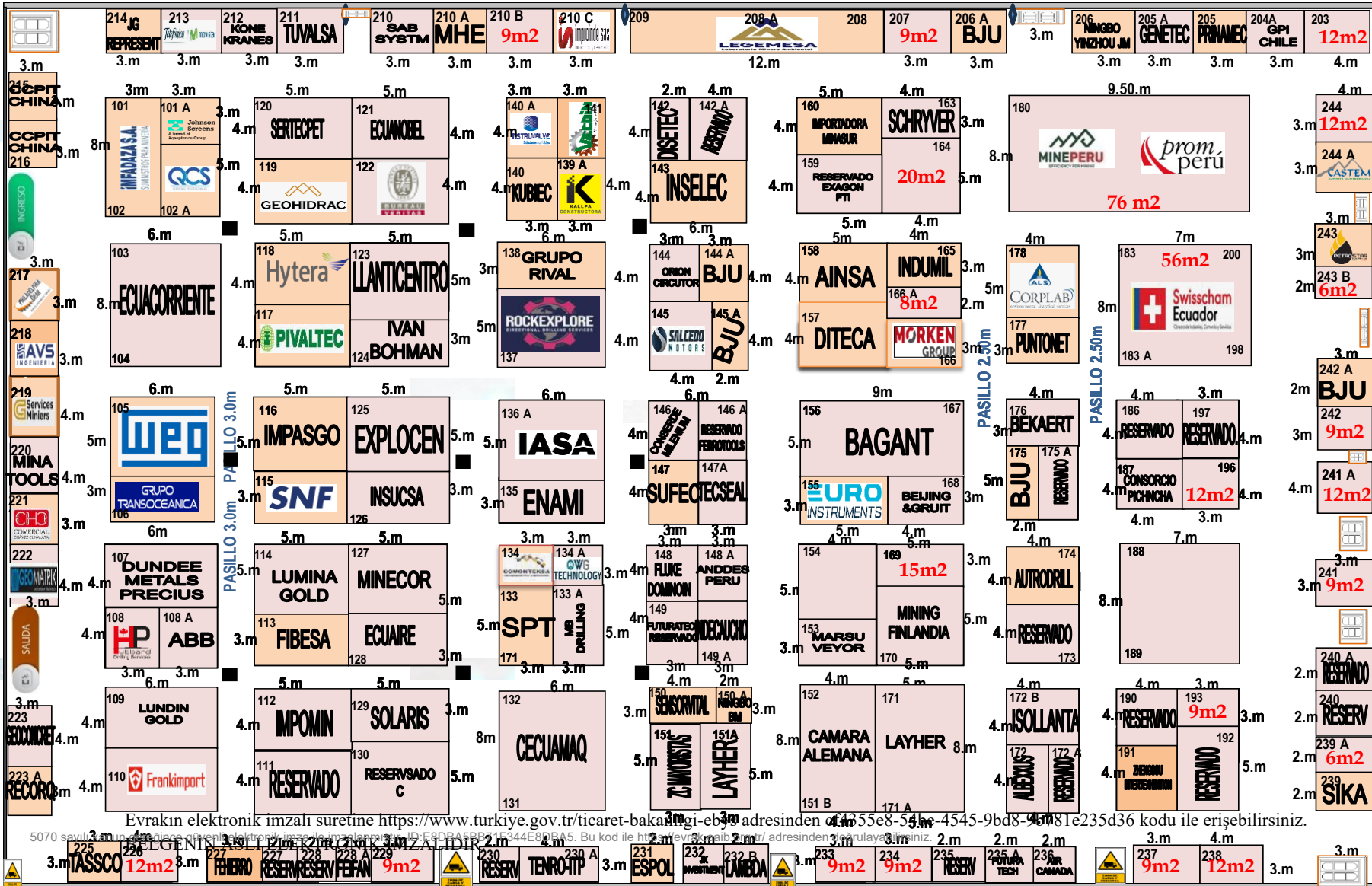

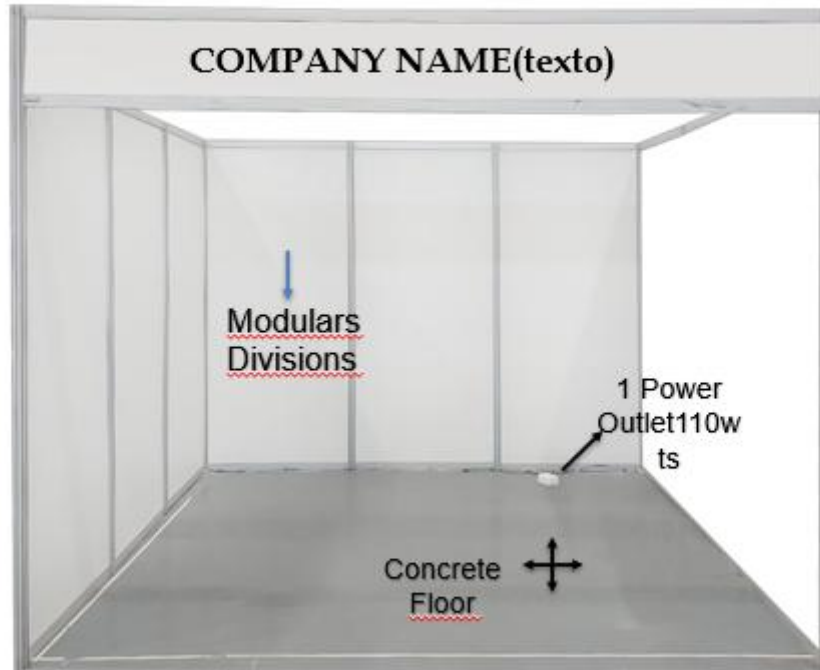

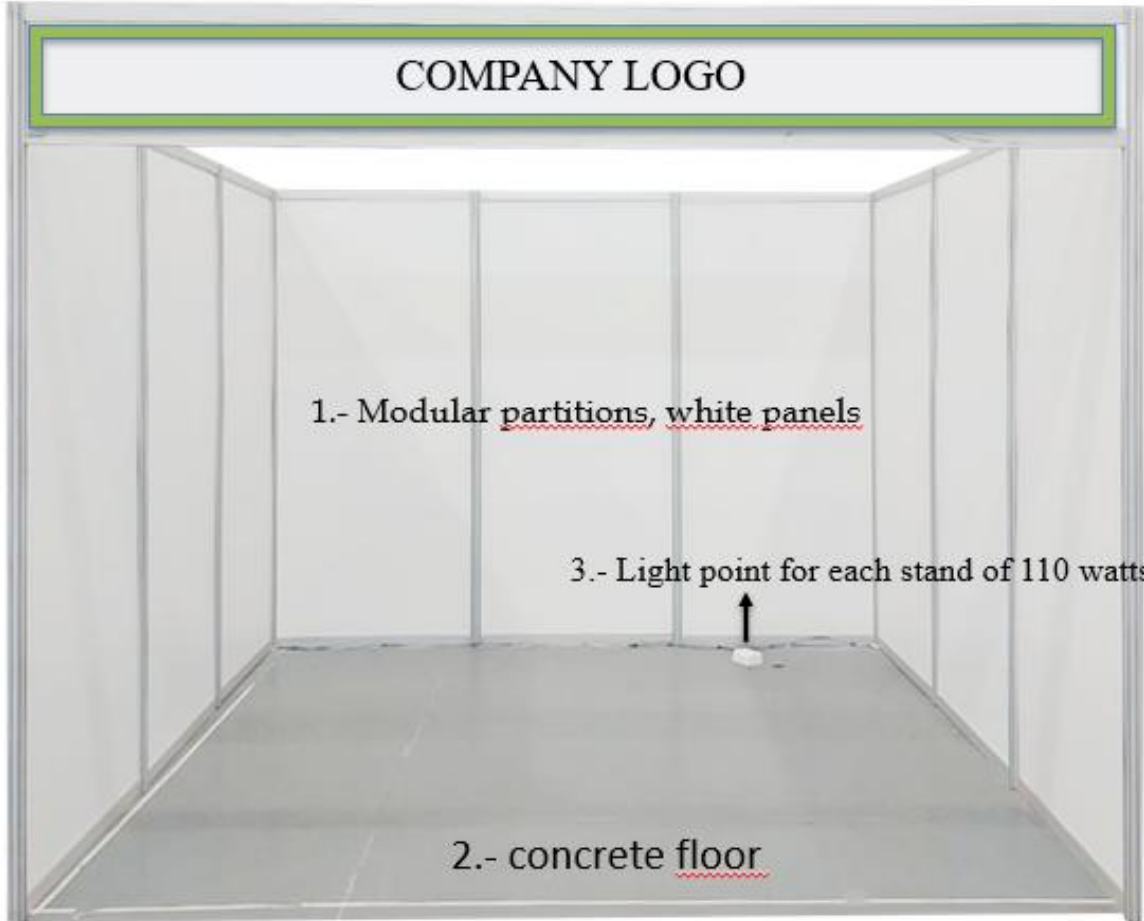
