Sayın Üyemiz,

Rusya Federasyonu'ndan Avrasya Ekonomik Birliği üyeleri haricindeki üçüncü ülkelere yönelik olarak;

-2306.30 gümrük tarife pozisyonlu ayçiçeği tohumu küspesi ihracatında gösterge fiyatın (ton başına) 13.875 rubleyi aşan kısmının %70'i oranındaki ihracat vergisi ve 15.875 ruble eşik fiyat seviyesi,

-Ayçiçeği yağı (gıda amaçlı) ihracatında gösterge fiyatın (ton başına) 82.500 rubleyi aşan kısmının %70'i oranındaki ihracat vergisi,

-1206.00.990.0 GTİP'li ayçiçeği tohumu (tohumluk olmayan) ihracatında vergi tutarının 32.000 ruble/ton'dan az olmamak kaydıyla %50 oranında ihracat vergisi

uygulamalarının 29.08.2024 tarih ve 1173 sayılı Hükümet Kararnamesi ile 31.08.2026 tarihine kadar uzatılmasına karar verildiği iletilmiştir.

Bu defa, Moskova Ticaret Müşavirliğimizden intikal eden yazıda gayriresmi İngilizce tercümesi ekli 1640 sayılı Hükümet Kararnamesi ile (<http://government.ru/docs/56637/>) söz konusu ihracat vergisi uygulamalarının 31.08.2028 tarihine kadar uzatılmasına karar verildiği bildirilmektedir.

On amendments to certain acts of the Government of the Russian Federation

The Government of the Russian Federation **decrees** :

In paragraph 2 of the Resolution of the Government of the Russian Federation of April 6, 2021 No. 546 "On the rates of export customs duties on sunflower oil exported from the Russian Federation outside the member states of the Eurasian Economic Union" (Collected Legislation of the Russian Federation, 2021, No. 15, Art. 2598; 2022, No. 27, Art. 4864; 2023, No. 36, Art. 6741; 2024, No. 36, Art. 5466), the words "until August 31, 2026" shall be replaced by the words "until August 31, 2028".
