The event will aim to:

- Share country case studies, good practices and how achievements promote empowerment of women entrepreneurs and sustainable economic growth
- Identify the existing barriers to women’s economic empowerment
- Explore policy actions and recommendations to tackle obstacles to women entrepreneurship and strengthen the role of women in the economy

Women’s economic empowerment is key to ensure sustainable economic growth. Adopting a gender responsive approach and formulating strategies to include women entrepreneurs in economy are essential steps to integrate more women into production. Multiple barriers still exist that limit competitiveness of women-owned small and medium-sized enterprises (SMEs) worldwide, including digital gender divide, gender roles and non-monetary barriers. In general, far fewer women-owned SMEs are engaged in international value chains than businesses owned by men. However, women entrepreneurs’ awareness related to the importance of integrating in the global value chains is increasing. Therefore, it is important to ensure that women and women-owned SMEs would fully engage in the opportunities that flow from entrepreneurship.

Roundtable discussion will provide insights related to good practices on empowering women entrepreneurs in MIKTA countries, identify the persisting barriers in this field and explore policies to confront challenges discouraging women entrepreneurship.

Businesspersons, academicians, representatives from civil society organizations and policy makers are welcome as participants.
