On 15/03/2023, the entries below on the Sanctions List of individuals and entities subject to the assets freeze, travel ban, and arms embargo set out in paragraph 1 of Security Council resolution 2610 (2021) were amended following the 2021 Annual Review conducted in accordance with paragraphs 90 and 91 of resolution 2610 (2021).

The following technical amendments were implemented on all the entries below: in the field “**Other information**”, text was added as follows: Review pursuant to Security Council resolution 2610 (2021) was concluded on 8 November 2022.
