**EXPRESSION OF INTEREST (EOI) FOR REGISTRATION OF SERVICE PROVIDERS
(SHIPOWNERS/OPERATORS/CHARTERES/MANAGERS TO DEPLOY VESSEL(S) ON TIME
CHARTERING FOR THE FY 2022/2023.**

1. Introduction

The Mauritius Shipping Corporation Ltd (MSCL) under the Ministry of Blue Economy, Marine Resources, Fisheries and Shipping based in Port Louis, Mauritius hereby invites eligible ship owning companies/charterers/operators/managers to express their interest for a charter agreement to service the Indian Ocean region.

2. Objective of Chart Multipurpose vessel

The objective of this EOI is to enable MSCL as owners to charter (time chartering) a multipurpose container vessel (LOA less than 115m, two 30/35 tonnes cranes each or above, capacity of 300 – 350 TEUs (at least 25 reefer plugs) The shipbroker/shipowner shall provide a list of available vessel for chartering with an indication of its daily chartering fees.

3. Conditions

- The charter period shall be from 15 November 2022 to 14 August 2023 and renewable for a further 3- or 6-months' duration.
- The plying area is the inter-islands and the Indian Ocean region.
- The expected laycan period to be at Port-Louis at least one month before the start of the first contract.

4. Requirements

The MSCL is looking for time chartering a multipurpose container vessel, having, amongst others, the following key specifications: -

- LOA of less than 115 m
- When fully loaded, the vessel should not exceed 6.4m of draft
- Cargo deadweight should not be less than 3,500 metric tonnes
- Mounted with thruster/s
- Fitted with 2 Cranes (minimum SWL 30 - 35 tonnes)
- Preferably fitted with Hydraulic Hatch Covers
- TEU Capacity: 300 to 370, Homogeneous: 230/14t, Reefer Plugs: 15 – 25.
- The vessel shall be fitted with at least 25 reefer plugs
- Break Bulk Cargo Capacity - Approx. 600 to 1000 cbm
- The vessel should be able to carry Dangerous Goods onboard
- Bunker tanks capable of transporting 200 to 300 metric tonnes of Heavy Fuel Oil as cargo
- The vessel shall be classed by IACS.
- Drydocking and major repairs should not be undertaken during the charter period

5. Eligibility and Qualifications of Brokers / Owner

Bidders should be from reputable shipbrokers / shipowners having adequate expertise and experience in vessel chartering and should be conversant in the English language.
